What will you be doing as our new Project Delivery Manager?

Key Responsibilities:

- Assure CDM compliance of the scheme through a series of audits, checks and peer reviews.
- Creates, drives and lives a 0-Harm culture in the project team.
- Assists the Project Director in translating Programme level strategy into actual outcomes and with the lead planner ensure that team members are informed of requirements for individual part of the projects.
- Support the development of collaborative working relationships within the project teams and with our client, their stakeholders and the supply chain.
- Supports with coaching and team development.
- Support the delivery of the Cambridge Relocation Project through enabling and assembly phases ensuring that the project is kept 'on track' to agreed cost, time and quality parameters and any arising issues mitigated appropriately.
